Mainly about Ourselves.

OUR annual self-examination began last year on a somewhat low note, owing to the fact that our membership,—as judged by the number of current subscriptions which had been paid—showed a considerable falling off. At the same time we expressed the opinion that the appearance of the subscription list was entirely deceptive and that there was no falling off in the attachment of members to their Association. This estimate has been proved abundantly true. This year, as a result of an intensive campaign, we are able to record that the membership stands higher than ever before. School Swimming Sports.

The Seventeenth Annual Swimming Sports were held in the Corporation Baths, on Monday, October 8th, 1928.

Though everything went comfortably and pleasantly along, 1928 will not rank in history as one of the swimming vintage years. Close finishes were rare and no records were broken. The nearest approach to anything of the kind was when J. B. Bradley, in the Junior Length, exactly equalled his brother's record, set up last year. R. J. Whitfield had evidently taken the sports seriously in hand and very deservedly gained the Championship. His style is very good and he is a promising swimmer; if his times compare rather poorly with the record times it is probably due to the fact that he needs the larger physique which a year or two will give him. R. Fenwick's second place was a very plucky achievement.

For the second time in our history we had the pleasure of welcoming that charming gentleman and great man Mr. J. G. Hatfield. With characteristic kindness, he gave us a display of swimming which was a lesson and a delight. In his serious swimming we saw the poetry of motion exemplified in an element where it is particularly difficult. And how gracefully he beat the boys who swam against him in relay by ever such a little bit! In the amusing turns in which he was assisted by Mr. Wishart (to whom also we desire to offer our cordial thanks) he—and indeed his friend, too—were irresistibly funny. In the Palestine Crawl, by the delightful expression of his face, as it emerged coyly and apologetically from the water, we realised that he might have appeared before us in the capacity of a

character impersonator—or, perhaps, an actor. And how *could* one who moved through the water so gracefully, with so little apparent effort, make such a fearful disturbance of the element with such little result as he did in the burlesque learner's breadth?

At the end of the proceedings Mr. Hatfield presented the medals and certificates to the successful competitors, and also the certificates gained during the year for proficiency in the various grades.

To him and to all who worked for the success of the sports our cordial thanks.

Football and Cricket, 1927-8.

The Football Season was marked by a good measure of success, the full record of the first eleven reading as follows :—

Played 15, won 8, lost 4, drawn 3.

As the fifteen matches produced 123 goals (79 for, 44 against), spectators had no reason to grumble at the fare which was provided. Noteworthy victories were obtained against our friends from the Grammar School (9—2, 7—2) and against Ayton Friends' School (14—1), but the greater weight and experience of the boys from St. Mary's College, Middlesbrough, told heavily against us on both occasions. In the other matches, Darlington Central School were defeated twice, while two closely contested games against West Hartlepool Technical School ended in a narrow victory and narrow defeat respectively.

Of the players, Lowther was always outstanding, thirty goals (including six in one match, and five on three other occasions) representing a profitable season's work. After him, Reynolds and Nash were probably the most promising performers. The usual team was as follows :

The second eleven with a programme restricted to two matches against Gisborough Grammar School, one against Elwick Road School from Hartlepool, and one against West Hartlepool Technical School enjoyed four victories, with a goal record of 21 to 7. Here the team was :—

The newly established Rugby fifteen made a very satisfactory beginning, winning their matches against Henry Smith's and West Hartlepool Schoolboys by very substantial margins. In both these games our boys shaped excellently, and though there were faults here and there, these faults were entirely due to want of experience. Of the players, Briggs displayed a natural aptitude for the Rugby game, and Lowther at wing three quarter was exceptionally good. Lest, in years to come, disputes may arise as to the composition of our first Rugby fifteen, the list of players is appended :—

Of the six matches played, the Cricket eleven won four and lost two. Great Ayton Friends' School were defeated very easily on both occasions, a four wickets victory was obtained over Gisborough Grammar School, and a margin of four runs on our side was the

result of the game with West Hartlepool Technical School. In the return match, Gisborough won with six wickets in hand, and St. Mary's College exceeded the century in answer to our score of 69.

Here again, Lowther, who afterwards earned golden opinions with the Preston Cricket Club, was always to the fore, his 82 against Great Ayton being a sound and workmanlike effort. He received substantial assistance in batting from Downie, Ions, Beard, Thompson, and Davey, while Holmes and G. Sharp—another cricketer who seems destined to do great things—were his most valuable helpers in bowling.

Junior Forms' League.

The season 1927-28 has been unique in the history of the Junior Forms' League. In the first place, this is the only season during the League's existence when the competition has been won by the same form in each of the three terms. Both in the Autumn and Spring terms, III Sc. carried off the honours at football, though a change of Captains at Christmas, Ward resigning and giving way to Weedall, might have brought disastrous results. Apparently, Weedall was a very satisfactory choice, for his form, under his leadership, were just as successful at cricket as they had been at football.

There remains only one duty to perform, and that is to say "Good-bye" to the Junior Forms' League. For some years it has served its purpose, in that it has provided organised games for some hundreds of boys. With the whole school attending field together on Tuesday afternoons, it has, however, been felt that it would be better to arrange Junior House matches. Accordingly, the existing shields will be transferred to a competition on these lines.

House Matches, 1928.

BLUE v. BROWN. 2-2.

"Hallam, the Blue House right half, scored a wonderful goal from thirty yards out, followed by two from Lowther, the redoubtable Brown House captain. The Blues equalised by a disputed goal, some doubt existing as to whether McKechnie or Jackson gave the final touch. The second half consisted of an almost continuous bombardment of the Blue goal, in defence of which Ross worked desperately."

RED v. BLUE. 2-2.

"Very windy day. Blues, playing with the breeze, led at half-time by 2-0, both being scored by Reynolds, who made full use of his speed. In the second part of the game, Ward and Buckle (Red outside left and centre forward respectively) made the score two all, despite the valiant exertions of Aitken in the Blue goal. Downie, Holmes, Briggs and Edwards merited special commendation."

GREEN v. BROWN. 2-3.

"Lowther (Brown) shot three goals past Liddle, who had saved the Green citadel on many occasions. Sharrocks and King (after a

fast cross shot by Weedall) reduced the deficit, but, although the Greens had several chances, they failed to equalise. Rutledge, Parnaby, Nash, and Gibson caught the reporter's eye."

GREEN v. BLUE. 0-1.

"A draw would have been a truer reflex of the game. Reynolds got the only goal, Liddle making a good but vain attempt to save."

RED v. GREEN. 1-0.

"Downie (Red) scored by an 'undeniably clean shot,' and afterwards failed to score from a penalty kick. The Red House goalie made 'some good saves from goal line scuffles,' and Briggs and Rutledge often cleared the ball from the respective goals."

BROWN v. RED. 1-0.

"Before this last match, the Blue House with all their matches played, were in possession of four points, while the Browns and Reds had each obtained three points. A goal by Lowther (who was responsible for all the goals secured by his House in the competition) gave the Browns the points and the championship."

SEMI-FINALS.

WYNZAR V. GIBSON.

With the weather conditions ideal for tennis, the courts of the Stockton Cricket Club well nigh perfect, and the two players well matched, a keen struggle was witnessed. In the first set, which he won 6-2, Gibson was slightly superior, but Wynzar retaliated by taking the second set 6-3. In the final and deciding set, Gibson faltered after taking a commanding lead, but a great rally took him into the final for the third year in succession, 8-6.

LOWTHER V. MORRIS.

A not particularly brilliant exhibition of tennis—marked by a lack of energy, many double faults, and a too tardy revival by Morris—saw Lowther win on the Ropner Park Courts 6-3, 8-6.

LOWTHER V. GIBSON.

This (in the words of our expert) provided quite a good example of the singles game of the old-fashioned type. At the beginning Lowther held his own, and the first few games went evenly. Later, however, the superior back court steadiness of Gibson began to tell, and he finished the first set at 6-3. In the second set, Lowther sensed that his only chance lay in getting quickly to the net, but as he usually chose to make his dash forward after playing a ball short and weak, he was immediately lobbed. One or two errors of this kind, and their consequent punishment and he retired to the back of the court. Gibson continued to play steadily, and he finished the set and match 6-2.

Arising out of the Tennis Tournament, an innovation took place towards the end of the Summer Term. The pick of the players in the Girls' School opposed the best of the Boys, in 9 sets of 15 games each, at the Edward Robson Sports Field. At the end of the afternoon the boys had won the bulk of the 135 games, but in many of the sets they had to extend themselves to the limit to win, and in one set they were actually beaten. It was a thoroughly pleasing social event and one which might profitably be perpetuated.

Literary and Historical Society.

This society had another very active session, this being partly due to the institution of an inter-house debating competition, and partly to the self-sacrificing support accorded by the bulk of the Sixth form and particularly by the energetic Secretary, R. M. Aitken. But interest was not confined to these, Holmes, Ball, and Stainsby of the Fifth, and Sowler, Livingston, Bowen, and Proud of the Fourth, being all very active members. Stainsby indeed was again the winner of the 'free entrance scholarship' to the society, his impromptu speech being the best in the competition.

It is somewhat to be regretted that lectures proved so small a part of the programme, but even here good work was done, Byles, Pye, and Laws contributing papers on 'Evolution,' 'Bernard Palissy,' and 'Oliver Goldsmith,' respectively.

At the same time, the subjects discussed by the society have been many and various. Thus the Brown House persuaded us that 'Prohibition of Alcohol' was an absolute necessity, and later obtained the suffrages of the proletariat when they argued 'that it would have been better had America never been discovered.'

On the other hand, the Green House failed to convince us 'that wireless is prejudicial to public sanity,' but the Red House were more successful in their appeals for 'Motor Transport as a substitute for the Railway.' Later, the latter House, flamboyant in opinion as in colour, overcame the arguments of the more sober Blues in the motion 'that a continental Sunday is better than an English one.' A sense of modernism can here be detected. Hence, it is rather disconcerting to discover that in the inter-school debate with Middlesbrough High School, it was decided 'that a Classical Education is better than a Scientific one.'

The competition for the inter-house shield was very close: indeed no decision was reached on league principles, for Red, Brown and Blue tied for first place. Thus a knock-out competition had to be arranged under the ægis of arbitrators.

In this connection, the thanks of the Society are due to Mr. Munday, who officiated in the semi-final, and to Mr. Roberts, of the Grammar School, who took charge of the final, in which the Blue House representatives—Ross, Aitken and Holmes, to whom we tender our most cordial congratulations—achieved a well won triumph in their answer to the Red argument 'that the World's Progress is more apparent than real.'

Chess Tournament.

Eight enthusiastic players were attracted to this competition. Play in the first round was not marked by any distinction, Pye and W. Aitken winning their games very easily. In the semi-final Pye was drawn against Shields, and W. Aitken against R. Aitken. The first tie resolved itself into a fairly easy win for Pye, but the match between the brothers Aitken was fought with traditional Scottish dourness, and only after two keenly contested games could the elder boy claim the victory.

The final between T. B. Pye and R. Aitken was played off on the morning of the School Athletic Sports, before a select company of the Sixth Form, who followed the games with much interest. After a careful opening, Pye succumbed to superior strategy, with the result that the name of R. Aitken now appears on the "A. W. Welch" shield).

School Speech Day, 1927.

The Speech Day in respect of the 1926-27 Session was held in the Jubilee Hall, on 13th December, 1927, R. Roger, Esq., J.P., in the chair. The hall was crowded, as usual, and, in addition to musical items by the School Choir, the programme included the presentation by the members of the Dramatic Society of a short sketch entitled "Early Birds." The Headmaster's report was cheering in two respects especially. In spite of the adverse economic conditions obtaining in the district, boys leaving the Secondary School were readily absorbed in local industrial and commercial concerns, and further, while Dr. Crockett disclaimed any idea that examination results were a true criterion of a school's success, it was satisfactory to know that the aggregate of such successes in the session under review exceeded those of any previous year.

Outside the class-room, the session had been marked by the recovery of the Ropner Cup, by a particularly successful football programme, and by the breaking of no fewer than three records at the Swimming Sports. Among the doings of Old Boys, Dr. Crockett had to record the obtaining of two First Class degrees, one Second Class, three research degrees (including two Doctorates) and a Diploma in Education, together with qualifications in Law, Dental Surgery and Engineering, and he remarked that as he went over, year by year, the achievements of Old Boys, in various walks of life, he could not but feel that a school, the former pupils of which were playing so worthy parts in learning, industry, commerce and the professions, was fulfilling in no uncertain fashion the tasks laid upon it.

Mrs. B. O. Davies, J.P., gracefully and with kindly interest in the recipients, presented the prizes and certificates, and her husband, Alderman Davies, J.P., C.C., thrice Mayor of Redcar, gave the address. He congratulated the fortunate winners, and urged those who had not obtained awards to emulate the industry of those who had, for he believed it was willingness to prepare for opportunities by real hard preliminary work that was most needed in the world to-day. Those who complained loudest about the lack of reward in this life were, he held, in the main those who were least deserving of it, and he urged his younger hearers to see to it that, while they enjoyed their sport, they kept it in its place, and made it their chief endeavour to apply to the daily business of life a touch of that idealism without

which it would be both profitless and uninspiring. To the parents he tendered the advice that they must make the home the effective supplement of the efforts of the school; character was the goal to aim at, and the school's efforts would be vain if its lessons of conduct and habit were neutralised by domestic indifference to the best in life. The address was much appreciated and was supremely sane in its practical advice and inspiring in its wisdom.

OLD BOYS' REPORTS.

Annual Lecture.

The Annual Lecture, which as usual was given in the Jubilee Hall, proved to be of unusual interest for more than one reason. In the first place we had a record attendance even for an Old Stocktonians' Lecture, many (for whom no seats could be found) having to be turned away. The lecturer and subject were in a sense a new venture on the part of the Association and perhaps a risky one, since cowboys and cowboy life might seem a subject suited only to those for whom the picture hall provides a programme—romantic, remote and not too subtle. Mr. Escott North, however, a real cowboy, proved that fact can always be relied on to shame mere fiction, and that a careful description of the Wild West, as it is and as it has been, can hold enthralled not merely the schoolboy and the child but also those bigger children of sophisticated age, fathers and mothers. Superior scepticism was soon confounded and all were engrossed in a breezy, entertaining and withal charming account of what is after all the world of nature and the wilds,—a world which holds its claim on the hearts of all of us, however much town life and interests and civilized pursuits may have conspired to destroy it.

Poor Kiddies' Treats.

Fairyland is perhaps far removed from the world of sanity and sound commonsense; but it exists at rare times and in unlikely places; and what more unlikely place could be well conceived than the school gymnasium? But grant kind hearts, generous impulse, willing hands, and enthusiasm, and the 'gym' becomes a veritable Aladdin's cave, its harsh and formal outlines dissolved in the glow of a hundred lights carefully softened into mellow beauty. What a delight! A Christmas tree so enchanting that nature herself was jealous that she could not produce so rare a wonder; the balcony at last suitably clothed with large scale nursery pictures and a fearsome dragon, the kindly work of our own expert artist; the hospitable tables groaning under mountains of good things provided in as generous plenty as ever; grotesque creatures, in keeping with their surroundings, and creatures more grotesque because in mufti striving hard to keep pace with the traditional demand for many sandwiches and gallons of tea, and a crowd of jolly youngsters severely uncritical of our efforts, but robustious in their approval of every item designed to entertain them. The choral festival was far from being a hackneyed reproduction of the programme of previous years, and ended with a surprise in a remarkable whistling duet by two exalted members of the Association of whose accomplishments in this line we had not dreamed. Once

more Will Fleet mystified with magic and proved the eternal attractiveness of Punch and Judy. Father Christmas excelled himself and found the youngsters remarkably keen to greet him. On all counts, the two Christmas treats were the finest ever held by the Association.

* * * *

In connection with our Poor Children's Treats, it has not been our custom to mention any names. But we feel bound to break this rule in the case of Mr. Atkinson, Plumber, of Regent Street, who from the beginning has, free of charge, contrived our lighting effects. For the rest, it is sufficient to say that two Old Boys as usual provided one of the teas; that another Old Boy—again as usual—provided all the sweets; that there is one tree less in an Old Boys' plantation at Longnewton; that the labour of packing 220 parcels was willingly undertaken by our own experts; that we again called on our own firm of decorators; that our own well established troupe of comedians were once again to the fore; and that the result of our appeal for subscriptions far exceeded all our anticipations.

In fact, everybody vied with everybody else in helping forward a function in which it is regarded both as a duty and a privilege to take part.

The Annual Dinner.

If any traveller, entering the Queen's Hotel, about the hour of 7-25 on the evening of Thursday, December 22nd, 1927, had happened to turn to the left instead of to the right, he would have entered a large pleasant room, brimful just then of distinguished looking gentlemen, whom the intelligent traveller would have had no difficulty in recognising as men of light and leading; had our imaginary voyager been no stranger to the district the general air of alert intelligence would have forced him to the conclusion that this must be a gathering of Old Stocktonians; but had our friend possessed the acumen of a Sherlock Holmes or a Sexton Blake he might have carried his deductions a step further and probably would have correctly guessed, from the universal air of pleased anticipation, that he had hit upon the evening of the Annual Dinner. Yet a little while and anticipation had melted away into realisation. Into the dining-room we filed and took our places,—our officers at the High Table and with them the Associations' honoured guests, R. Roger, Esq., J.P., and Dr. McGonigle.

Not ours to enlarge lusciously upon the pleasing gastronomic sequence of tomato soup, sole à la maître d'hôtel, sirloin of beef, roast turkey and cranberry sauce (cranberry sauce forsooth!), custards, wine jellies, cheese, celery and coffee! In British social life these things are but the means to an end—the promotion of the flow of winged words of genial reminiscence, of kindly recognition, of irresponsible chatter.

To feed were best at home;
From thence the sauce to meat is ceremony.

We must take it, then, that the pleasing meats—and drinks—have done their work, that tongues are loosened, hearts have expanded, the loyal toast has been drunk, and the main business of the evening is ready to begin. This main business (stay? Is it the main business?)

Opinions differ. But no matter!—this main business lies in the proposal of two toasts, "The Old School" and "The Old Stocktonians," and in reply to the speeches of their proposers.

The toast of the Old School was in the experienced hands of Mr. Horace J. Ward. At first we were somewhat at a loss; Mr. Ward appeared to be justifying himself where no man accused, but as he assured us that his speech would contain no word to offend the most sensitive of "candidates for canonisation," we regretted that we had missed an opportunity (which might not recur) of bringing our sisters and aunts to hear Mr. Ward. None the less, we enjoyed his very interesting reminiscences of the days that were, and under his able guidance we endeavoured to recapture something of that spirit which has lightened moments of darkness in the past and which will help to brighten days still to come. Mr. Ward shows promise as an orator and should go far.

It fell to the Headmaster to reply. He divided the staff of the school into two parts—the many lean kine and the few who were fat and well liking. He identified himself with the latter and, bewailing (with Hamlet) that he was fat and scant of breath, he told us not to expect a long speech from him. He was able to give us his personal assurance that all was well with the school, and that as we looked back with pleasure to our own school days, so present pupils would have quite as good reason to reminisce when they, in due course, reach their anecdotal age.

To our old friend, Mr. Robert Roger, it fell to propose the toast of the Association. He reviewed the great change which had come over the face of education since his own schooldays and thought the time had come for children seriously to undertake the education of their parents; he believed that many parents could find a new interest in life if they would investigate the studies on which their boys and girls were engaged, for there were several subjects well within their grasp, and thus both pupil and parent would benefit. We forbear to repeat the kindly words which Mr. Roger said about us; his opinion of us is always too favourable and he is in danger of making us conceited. Our President, Dr. E. Mackenzie-Taylor, with blanched face, repudiated the very suggestion that he should attempt to educate *his* parents, and the Old Boys looked towards the spot where Mr. J. G. Taylor sat, and a collective and sympathetic shudder of horror ran round the assembly at the very prospect. The President admitted, however, that in every difficulty he was more than ready to take counsel with his father, though, in common with other young people of the twentieth century, he by no means invariably followed the advice which was liberally bestowed upon him.

After this speech there came a pleasing little episode. To Mr. Roger—in order that he might give it to Mrs. Roger—was presented a framed copy of the photograph which appeared in the Year Book of 1927. In accepting this little gift, Mr. Roger showed that he was genuinely touched. It must be rare indeed for anyone, whose connection with a body such as ours, was, at any rate in the first instance, an official one, to succeed in inspiring such feelings of personal regard as the Old Stocktonians feel for Mr. Roger. In him we see a standard of gentlemanly courtesy which may be our ideal and our aim.

But let not those who should have been at the dinner but were not think that our post-prandial activities were confined to listening to speeches. As usual we sang with our accustomed vigour Calverley's "Ode to Tobacco" and "Forty years on," and this year, for the first

time, we went further and rolled out in fine fashion the good old choruses "John Peel" and "The Vicar of Bray," to the admiration of all within sound of our lusty voices and to the envy of more ambitious attempts at community singing. Nor was this all, for Messieurs Bertram, Riley and Ward—picked voices all these—entertained us with light music married to facetious verse. And time sped fast, and after all the 55 diners—(better this than for the last year or so, but still not numerous enough)—had sung "Auld Lang Syne" we turned our several steps homeward, all feeling as did Mr. Ward's curate (perhaps not a candidate for canonisation this one, in spite of his orders), that it really *was* a most delightful evening.

Old Stocktonians' Benevolent Fund.

The lamented death of Mr. L. T. Winn removed from office a Trustee whose assiduity in business, no less than his sympathy, discernment and sincerity of character, had amply proved how suited he was to the post which he held. The vacancy thus created was filled by the election of Mr. N. Winn.

Reference to last year's *Stocktonian* will show that the Fund started the year 1927-28 with a balance of £41 13s. 6d. brought forward. The surplus from the Children's Treat amounted to £10 12s. 3d., Contributions totalled £11 9s. 0d., the sum of £1 was repaid, and the Dance brought in the very handsome addition of £30 5s. 8d. From the foregoing it therefore appears that the Charge side of the account shows a total of £95 0d. 5d. On the Discharge side, actual disbursements have been low, the total being only £4 2s. 6d., but the Trustees are committed to a loan not in excess of £20. That loan has not, in point of fact, yet been made, but it represents a commitment in the year under review. The cash balance at the bank, however, is £90 17s. 11d., a very satisfactory state of affairs.

The Trustees hope that the increasing balance will not deter possible benefactors from translating their generous impulses into cash gifts. A sum of a £1,000 would not be too large a credit, and, as the members of the Association know, the chief concern of the Trustees meantime is to see the Fund grow to ample size, when it will be possible to render help, the repayment of which, if deferred, will not unduly hamper their operations.

Dance in aid of the Benevolent Fund.

This Dance, which was held in March, in the Maison de Danse, was undertaken with considerable trepidation by the Association, inasmuch as the dancing season was almost over and inasmuch as a previous function had not proved very successful. A strong working committee was, however got together, and these, together with their ubiquitous secretary, Mr. James Graham, to whom we extend our cordial congratulations, carried all before them. Altogether about 360 people took part in the dancing and thoroughly enjoyed themselves, while the much deserving Benevolent Fund benefited to the extent of over £30.

It is with very great regret that we have to record the loss to the Association of Mr. L. T. WINN, who was taken ill with pneumonia in the early part of this year and died on January 20th. Almost his last appearance was at the Annual Dinner, in the Queen's Hotel. On that occasion, Dr Taylor (the president) was forced to leave early, and Mr. Winn took over the duties of chairman till the close. One of the original members of the Association when it was founded in 1913, he never lost interest in it, and as President, Vice-President, Secretary, or member of the Committee, he was always found ready and willing to do anything in his power to make it a success. Few have given such ungrudging and capable support to the cause of the Old Stocktonians. Devoid as he was of any self-interest, loyal to old friends, absolutely incapable of a mean or petty action, imbued with a strong sense of duty, his loss seems irreparable. During the war, he served with the Royal Engineers in France, Egypt, and Palestine, and it was during active service in the Jordan Valley that he first fell a victim to malaria. From this recurrent malady, he was never absolutely free, and undoubtedly this helped to weaken his constitution. He will long be remembered with affection by all those who were privileged to know him, for he leaves behind him nothing but pleasant memories of tasks well done, of a life well lived.

* * * * *

Twelve or fourteen years ago one of the most popular boys in the School was GEORGE BERRY SMITH, who was drowned at Marske on Aug 11th, under particularly distressing circumstances. Cheerful and courteous in disposition, a gentleman in the true sense of the word, Mr. Smith, who held an appointment in London, was on the threshold of a most promising career, and his tragic death, at the early age of 29, will be deeply regretted not only by his own immediate friends but by all Old Stocktonians.

RULES.

Old Stocktonians' Association.

Revised October 30th, 1925.

1. The name of the Association shall be the "Old Stocktonians."

The "Old Stocktonians" aims at continuing friendships and preserving that spirit of comradeship which ought to exist among those who have been educated at the same school. These aims are to be achieved by means of social, recreative, and educational pursuits.

2. The Association shall be open to the Old Boys of the Stockton Secondary School and of the late Higher Grade School. Past and Present Masters are also eligible.

3. The government of the Association shall be vested in three Presidents, six Vice-Presidents, a Treasurer, two Secretaries and a Committee of sixteen, together with the Secretary of each sub-section.

(a) The present and retired headmasters shall be Presidents ex officio. The third shall be elected annually.

(b) All the other officials shall be elected annually.

(c) A member holding any office shall be eligible for re-election in the following year, in the same or any capacity.

(d) In Committee seven shall form a quorum.

(e) The Committee shall have power to co-opt any member or members at their discretion for the time being for any particular purpose.

4. The Committee shall have power to refuse membership to any applicant for admission or to ask any member to resign (after investigation by the Committee and confirmation by a general meeting), whose conduct they consider such as to militate against the welfare of the Association.

5. Each Section shall be self-governing and self-supporting. The Committee, however, shall have power to grant financial aid to any Section.

Each Section shall submit its programme to the General Committee for approval.

6. The Annual Subscription shall be one shilling, payable to any member of the Committee, before January 1st. In lieu of an Annual Subscription, a Life Subscription of twenty-five shillings may be made.

7. These Rules shall be altered only at the annual general meeting, and then only by a two-thirds majority; all motions of such alterations to be in the hands of the Secretaries four days before the date of such meeting.

8. The Annual General Meeting shall be held in September or October.
